- IV. Advocacy opportunities
- a. March Tri-Societies Congressional (legislative) Visits (approve payment for graduate student to accompany est. <\$2,000)

Rich Pratt has participated in these visits. His opinion is that this will be a valuable experience for a student, and provides a shared experience with the tri-societies.

Donn Cummings "How would the process go to identify the student". "DF: Competitive nomination process vetted through the advocacy committee". Donn "This is the type of thing that NAPB should be supporting on a routine basis". Motion to fund travel opp. (Klaus), second Don Blackburn. Unanimous vote.

b. OSTP Event (Klaus)

Oct. 9th call with OSTP (Joe Handelsman, Elisabeth), American Soc. of Agronomy, ASTA, and others. There will be two events, Dec. 1 White House event (brain storming), Second event in January-February. The December event will be focused on Agriculture in general, organizing public-private partnerships, an activity designed to enhance the visibility of agriculture in general. The notion of stem into STEAM with A = agriculture. Plant Breeding would be a small part of this meeting. What has been successful (past), and what would be new models?

Klaus: suggestion connect to ASTA (Andy L) and think about next steps. David: focus on what has been successful in the past and what would be new models.

David reported on the SAES meeting; "ask Land-Grant Universities to be ready to respond with letters of support"

Kate Evans: OSTP survey about the Nations Capacity to Educate and Employ Plant Breeders (Jamie Sherman). Kate will forward the link. NAPB should be prepared to lead distribution and publicity of this if appropriate.

The IDA Science and Technology Policy Institute (STPI), a Federally-funded R&D Center supporting the White House Office of Science and Technology Policy (OSTP), is currently conducting a study on behalf of OSTP on the United States' capabilities in educating, employing, and filling the nation's needs for plant breeders. It is crucial that we are able to collect accurate information from the colleges and universities that are training and employing plant breeders and we are asking you to assist us by participating in a survey.

As part of our study, we're trying to understand the state of public sector plant breeding. We have identified Montana State University as an important contributor. Our survey, which includes a maximum of 21 questions, requests institutional information as well as judgement-based questions.

We recognize that some of the information for this survey may require data collection from your department. We request that you not give guesses as answers to questions but provide only verified data. Please feel free to revisit the survey as often as needed before October 31st. The survey will save your responses, and clicking on the link will return you to the survey at whatever state you last left it. The last question of the survey asks whether you are finished with your answers. Please do not indicate "yes" or hit "submit" until you are comfortable with the answers to your questions.

ii. Unified Message Meeting (participate?, who?, pay?)

Unified Message Meeting. The December 9 meeting is one of a series of efforts led by the Charles Valentine Riley Memorial Foundation (RMF) aimed at pursuing a unifying message to elevate food, agricultural and natural resources research as a national priority. The person you select to represent your society will engage in a facilitated conversation on the critical need for a unifying message, share the perspective and priorities of your society and contribute ideas and insights to moving forward toward a common goal. The attachment to this email has more background and details, including a list

of all societies invited. Again, the scientific societies need to be a key partner in this discussion and defining the way forward. RSVP by November 2.

Noted that ASTA meetings are right in the middle of this "unified theme" meeting.

VI. PBCC Update (Kate Evans)

1. Update on "<u>Unlocking Plant Genetic Diversity for Food and Nutritional Security</u>" Symposium at the AAAS 2015 Annual Meeting in Washington, DC.

PB reported confirmation of 3 speakers: Chiedozie Egesi, National Root Crops Research Institute, Nigeria (Bringing Cassava Breeding into the 21st Century); Paula Bramel, The Crop Trust, Bonn (Crop Diversity: Why it Matters)); Walter Trevisan, Retired private sector maize breeder (Increasing Genetic Diversity in Public- and Private-Sector Maize Breeding World-Wide)) for the morning session on Saturday Feb 13th. As soon as the final program is released, PB will develop a PBCC paragraph for the PBCC and NAPB websites with a link to the AAAS, and send to Todd Campbell for the next newsletter.

Action: PB to communicate program information when finalized.

2. *PBCC has been granted liaison status on the National Plant Germplasm Coordinating Committee.* Pat Byrne will represent at the 2016 meeting in Fort Collins.

3. Meeting of the <u>National Genetic Resources Advisory Council</u> PBCC is trying to determine the best way to provide comment – possible route includes finding out how the questions are released in advance to enable written response, and open question time as it's a public meeting.

4. How best to update and expand the state representative list, Appendix E? How to increase engagement and participation in the renewal?
